Accuplacer Request to Test for WSCC Courses

- Testing is permitted only after 1) WSCC online application has been verified submitted (veterans do not need to resubmit), 2) Student Parent Acknowledgment Form is submitted with signatures to the Guidance Office (veterans do not need to resubmit), and 3) Letter of Intent submitted to the Guidance Office (must be turned in each year).
- These are the WSCC CCP Courses Offered @ FFHS traditionally taken at this grade level.
- If you do NOT test college ready for any desired course then after 2 hours of documented review you may request to retest.
- If you wish to attend classes @ WSCC then the test may still be taken @ FFHS.
- WSCC Liaison is Chey Parsons College Pathway Advisor. All online and face to face WSCC courses must be coordinated with her. All FFHS on campus course will be coordinated via the guidance office.
- Keep in mind that students may be transcripted in to other classes after having entered the CCP "Door." (COVID relaxed rules for CCP Eligibility include 3.0 cumulative unweighted GPA.)
 - Comp I with min 2.75 overall GPA and 3 years HS English with B average
 - Math with min 2.75 overall GPA and B average in Algebra I & II
